Thank you for test driving the first segment of the ICC/MD 200. As part of a promotional period, from **Wednesday**, **February 23** through **Sunday**, **March 6**, all tolls and service charges have been waived!

The ICC was specifically designed to help ease traffic congestion and can save you time and get you where you're going more quickly and easily. The ICC is Maryland's first all-electronic toll road that uses highway-speed toll collection—there are no toll booths. Having an *E-ZPass*® is the most convenient way to travel the ICC.

Video tolling is an alternative to *E-ZPass*, but is not recommended for frequent travelers. With video tolling, the toll amount, plus a \$3 Notice of Toll Due service charge per transaction, is sent to the registered vehicle owner for payment.
